This policy sets out our overarching commitment to our environmental, social and governance (ESG) matters, and supports the principles upon which our Net Positive responsibility strategy is set. The Net Positive strategy is designed to put more into society, the environment and the economy than we take out. All our people have an obligation to live our values, delivering our services responsibly for the good of the business, our people, our customers, our supply chain, our environment and our communities. These principles are founded on the following commitments:

Governance

- As a minimum, comply with all relevant legislation and regulations.

- Engage our supply chain and business partners to make them aware of our approach to responsibility and understand how they can support us.
- Communicate and make available to all our people our Net Positive strategy and provide support and access to learning relating to environmental and social matters.

 agenda and actively consider how we can contribute towards a reduction in our customers'

- Be accountable and transparent in our sustainability performance through the publication of our annual performance and activities.
- Provide leadership and embrace industry-wide collaboration on ESG issues through our partnership with the Supply Chain Sustainability School
